

Types of Gifts in Wills

If you are thinking of leaving a gift to National Foundation for Australian Women Limited in your Will, there are many ways you can leave a gift that could be the right fit for you.

A few examples that may suit your preferences and individual circumstances include:

- A specific sum of cash
- A percentage of the value of your estate, or
- A residual gift (the balance of your estate after all other provisions have been met)

How To Leave a Gift in Your Will

A Will must be carefully planned, drawn up, and executed to ensure your wishes will be effectively carried out.

National Foundation for Australian Women recommends you seek professional advice when preparing your Will. You can contact a solicitor, the Public Trustee, or the Law Society in your State or Territory for advice about preparing a Will. Thank you for considering supporting the NFAW with a bequest.

By leaving a gift in your Will to National Foundation for Australian Women Limited, you will be making a unique commitment to ensure National Foundation for Australian Women Limited can continue advancing and protecting the interests of Australian women in all spheres, including intellectual, cultural, political, social, economic, legal, industrial and domestic.

Wording to make a bequest in your Will

Percentage

"I give to National Foundation for Australian Women Limited ABN 32 008 659 630 (NFAW) _____% of my Estate free of all duties for the general purposes of NFAW, and the receipt of the Secretary or Treasurer (or other proper officer for the time being) of NFAW shall be sufficient discharge for the executor and the executor is not bound to see to its application."

Residual

"I give to National Foundation for Australian Women Limited ABN 32 008 659 630 (NFAW) the residue of my Estate free of all duties for the general purposes of NFAW, and the receipt of the Secretary or Treasurer (or other proper officer for the time being) of NFAW shall be sufficient discharge for the executor and the executor is not bound to see to its application."

Specific Sum

"I give to National Foundation for Australian Women Limited ABN 32 008 659 630 (NFAW) the sum of \$_____ free of all duties for the general purposes of NFAW, and the receipt of the Secretary or Treasurer (or other proper officer for the time being) of NFAW shall be sufficient discharge for the executor and the executor is not bound to see to its application."

Once you have a Will, it is important to keep it up to date to reflect your current family situation and intentions.

If you already have a Will and would like to support NFAW without rewriting the entire document, a codicil to your Will may be a simple option – please seek advice from your solicitor.
